

Prof. Ngugi wa Thiongo (PhD) is a Distinguished Professor of English and Comparative Literature, English (African and Caribbean literature, theatre and film, performance studies, cultural and political theory at the University of California, Irvine. The legendary post-colonial African writer is also a literary and social activist. He writes plays, novels, short stories, and critical essays. His writings also deal with the cultural and political legacy of colonialism in contemporary Africa. He was educated at Kamandura, Mangu and Kinyogori primary schools; Alliance High School, all in Kenya; Makerere University College (then a campus of London University), Kampala, Uganda; and the University of Leeds. Prof Ngũgĩ wa Thiong'o is also an Honorary Foreign Member of the American Academy of Arts and Letters, 2003 and a member of the American Academy of Arts and Sciences, 2014.




Prof. Godfrey W. Netondo

He holds a Doctorate Degree in Plant Physiology and Biochemistry (Maseno University), Master of Science in Botany (University of Nairobi) and Bachelor of Science in Botany and Zoology (University of Nairobi). Prof. Netondo is a member of Kenya National Academy of Sciences and Kenya DAAD Scholars Association (KDSA). His research interests include environmental plant stress physiology, agro-biodiversity conservation and ecosystem services nexus. He has supervised 15 master's and 6 PhD students to completion. 


Dr. Khanyisile Litchfield Tshabalala

Prof. Beatrice Were (PhD) is the former Ag Vice Chancellor of Academic Affairs, University of Eldoret. Her main Disciplines include Genetics, Biotechnology and Molecular Biology. Her Skills and expertise are in the areas of Genetic Diversity, Population Genetics, Molecular Markers, and Plant Breeding, with a focus on Plant Biotechnology, Genetics, Molecular Biological Techniques, Biotechnology, Cloning, PCR, and Sorghum. A plant scientist by training, her areas of research interest include genetic diversity studies, molecular biology, crop breeding, agronomy, agroecology, biofertilizer and biopesticide technologies. Her current research focuses on the improvement of crop resistance to biotic and abiotic stresses through resistance breeding and the integration of environment-friendly technologies into the management of ecological stresses facing crop plants. As an educator with more than twenty years of teaching genetics/plant breeding, her primary goal is to meet the distinctive learning needs of her students for them to achieve their academic goals.

Prof. Munyaradzi Mawere (PhD), is a Professor Extraordinarius of Interdisciplinary Research (UNISA), and a Full Professor of African Studies at Great Zimbabwe. Prof Mawere holds a PhD in Social Anthropology (UCT), an MA in Philosophy (UZ) and an MA in Development Studies (GZU), as well as several professional certificates. His research interests cut across disciplines such as African studies, philosophy, cultural studies, sociology/anthropology, development studies, knowledge studies, climate change, entomology, and political science. Mawere has more than 270 publications to his credit, including more than 70 books, over 200 book chapters, and peer-reviewed journal articles published with internationally acclaimed publishers. He has won several awards, including the internationally coveted African Studies Association Presidential Fellowship Award (2017). His most recent book is entitled: *Covid-19 manifestation, ramifications, and future prospects for Zimbabwe – a multi-disciplinary perspective*

Dr. Khanyisile Litchfield Tshabalala (PhD) is the African Parliamentary Network on Illicit Financial Flows (APNIFFT) Continental Chairperson. A retired Rear Admiral Junior Grade, she stands out as a multifaceted professional encompassing roles such as facilitator, trainer, public speaker, writer, and consultant. Her expertise spans illicit financial flows and tax, with a keen focus on international finance institutions' transparency, accountability, and community engagement. It extends to other areas, including public debt and the development of finance institutions' transparency and accountability, feminism (which she has defined for herself in her first book as Afro-gender), decoloniality, African Spirituality and culture, precolonial African history, as well as activism for social and economic justice. Dr. Litchfield-Tshabalala's unique dedication to Africa, often prioritizing it above personal interests, is well-known among her peers and those who have worked with her. Her illustrious career began as a veteran of uMkhonto WeSizwe and an exiled freedom fighter, culminating in her historic achievement as the first female admiral in the South African Navy. Following her naval career, she continued to serve in the public service in various roles as the Gender Focal Point for the Gauteng Provincial Department of Infrastructure and Development, as the Project Manager of the National Youth Service under the Department of Defence, and as a Member of Parliament under the Economic Freedom Fighters. Through 16 years of public service, she specialized in human resources, gender mainstreaming, equal opportunities, equity, and mentorship, as well as transformation and institutional, cultural dynamics and change.







Prof. Bruce Mutsavairo

Prof. Bruce Mutsavairo (PhD)n is a Full Professor and Chair of Media, Politics, and the Global South in the Faculty of Humanities Department of Media and Culture Studies, Utrecht University. A co-editor of two Springer International Publishing book series (link 1 & 2) and jointly published over 30 books focused mostly on the journalism, media, and communication research fields. (co)-authored or (co)-edited over 20 scholarly books and special-themed issues in high-impact journalism and media journals. 
Prof. Mariama Awumbila

Prof Mariama Awumbila (PhD) holds a Ph.D. (Geography) from the University of Newcastle Upon Tyne, UK, and teaches at the Department of Geography and Resource Development and at the Centre for Migration Studies, both at the University of Ghana. From 2006 to 2013, as founding Director, she nurtured the establishment of the Centre for Migration Studies into a full-fledged University Centre, undertaking extensive migration research, teaching and capacity building, and extension services. 



He is also a Research Associate at the African Diaspora Policy Centre (ADPC) in The Haque, where his research focuses on Governance of migration, diaspora engagement policies, migration, and development. He is an associate researcher with Globalization, Accessibility, Innovation and Care (GAIC) at the Tilburg School of Humanities and Digital Sciences (TSHD) Tilburg University, and for the last 8 years, he has been a member of the Commission on Development Cooperation (COS) of the Advisory Council on Foreign Affairs (AIV) of the Dutch Ministry of Foreign Affairs. Odilia Anyachi Okonga (BSc) Odilia is a passionate advocate for educational reform in Africa. She passionately believes that education is the most powerful catalyst for change on the continent. She is a resolute proponent of an African-centered curriculum and is committed to amplifying African voices and images within educational contexts. Odilia's leadership and initiative are evident in her role as the founder of the International African School (IAS) (https://internationalafrican.school/), an Online School that teaches Swahili as a second language and Social Studies with a focus on African History, Civics, culture, and literature. Odilia's scholarly contributions to African education are significant. As a published author of Swahili grammar books in English, French, Dutch, and German, she has made substantial contributions to the documentation and advancement of resources for integrating African perspectives into the classroom. Based in the Netherlands, Odilia is a freelance teacher. She introduces the Discovering Africa Program in primary and secondary school classrooms. Through the art of storytelling, she skillfully utilizes African folktales to impart invaluable lessons in civics and history. Odilia has significantly promoted African culture and knowledge through various impactful initiatives in The Netherlands. She was honored to present the African concept of Ubuntu philosophy to over two thousand individuals in 2023. Furthermore, in 2023-24, Odilia curated an insightful African Textile exhibition at a prominent museum in The Netherlands titled "Discovering Africa Through Textile," highlighting African textiles' rich and diverse heritage. Her commitment to promoting African culture is further evidenced by her publication of Sauti ya Afrika Magazine, which focuses on curating African culture and narratives. Before her current endeavors, Odilia also contributed her expertise to a UN organization for more than 10 years, furthering her impact on a global scale. Her multifaceted contributions continue to make a positive and lasting impact on promoting and celebrating African culture and education. She is one of the founders of KEMET Awards for Achievement in African Languages (KAAAL Awards), an initiative that recognizes, archives, and honors the achievements and development of African mother tongues.

Prof Auma Okwany (PhD) is an Associate Professor of Social Policy at The International Institute of Social Studies of Erasmus University Rotterdam in The Netherlands. Her scholarship centers on the relationship between policy, practice, and theory for children, youth, and their families in diverse areas including a gendered analysis of education, social protection, (adolescent/youth) sexuality and reproductive health and rights, Relational Learning and Place-based Pedagogies. Her scholarship building privileges research that is attentive to epistemic diversity, highlighting the need to center and amplify voice and experiences which are often marginalized by the dominant narrative. In this endeavor of pursuing epistemic justice, she has built alliances with scholars in the African region in nurturing and mentoring emerging researchers on situated approaches. Her research outputs include articles, book chapters, and edited volumes including a book that she is currently editing for publication by Routledge. Using her scholarship to improve policy and practice, she has been involved in coordinating several externally funded multi-year, multi-partner research, development, and capacity building projects in East, South and West Africa.








Dr. Leonard Muaka

Dr. Leonard Muaka (PhD) is the Chair, Department of World Languages & Cultures. Prof Muaka is an accomplished linguist, researcher, academic leader, professor of Swahili, and experienced study-abroad leader. He currently leads and teaches languages at Howard University in Washington, DC, USA. He holds a Ph.D. in Linguistics from the University of Illinois, Urbana-Champaign, and an Advanced Certificate in Second Language Acquisition and Teacher Education (SLATE) from the same Institution. In addition, he also holds a master's degree in Swahili Studies from the University of Nairobi and a master's degree in applied Linguistics from Ohio University, USA. His research focuses on African languages, language acquisition, youth languages, and sociolinguistics in general. Dr. Muaka's experience of more than 30 years of teaching Swahili as a foreign language is what is needed to attract foreign language learners and to provide training to future educators in the field. He currently directs the Fulbright Swahili Group Project Abroad to Kenya for American students to study advanced Swahili. This is a very competitive federally funded study abroad project.



Dr. Rahab Njerii

Dr. Njeri Rahab (PhD) is a mother, historian, decolonial scholar, and community activist. She earned her PhD from the University of Trier through the International Excellent Graduate School IRTG (funded by DFG), following her studies at the University of Cologne. Her research interests include Postcolonial and Gender Studies, Intersectionality, Black Feminism, African History, Critical Whiteness Studies, Black Diaspora, Migration Studies, and Black Canadian Studies. As a trainer, Njeri specializes in Critical Whiteness, Anti-Black Racism, Critical Intersectional Diversity, and Empowerment. In her roles as moderator, curator, and trainer, she applies a decolonial lens to the complexities of race, gender, and power, creating inclusive and transformative spaces for dialogue and action. Njeri is actively engaged in the restitution debate in her city, advocating for the return of cultural heritage looted during colonialism. She serves on the board of several organizations, including the Health Committee of the City of Cologne, Postkoloniales Erbe Köln (Postcolonial Heritage of Cologne), ANSA e.V. (DAAD), International African School, and Women of Impact. She is one of the founders of the African Institute of Professional& Development Studies (AIPDS) and currently, also working to institutionalize Black Studies within German academia. Deeply involved in grassroots climate movements, Njeri brings a decolonial perspective to climate change activism. She is a strong advocate for the inclusion and visibility of Black women in climate policy discussions and has delivered several presentations on the contributions of Professor Wangari Maathai and Indigenous knowledge systems to current climate politics in Germany, promoting sustainable solutions rooted in equity and justice. In 2020, she ran for a political seat as a direct candidate for City Hall, representing the environmental political group Klima Freunde. An advocate of the Utu philosophy as articulated by Prof. Micere Githae Mugo, Nieri advocates for social justice, equity, empowerment and critical diversity in German higher education policy and strategy. She employs an Utu-centred decolonial framework to address issues of racism, coloniality, and exclusion, striving to dismantle oppressive structures across academia, society, and politics while fostering solidarity and critical allyship. Njeri is the founder of the KEMET Awards for Achievement in African Languages (KAAAL Awards), an initiative that recognizes, archives, and honours achievements in African languages both in the diaspora and on the continent. Under the patronage of renowned intellectual Prof. Ngũgĩ wa Thiong'o, KAAAL foregrounds the significance of African languages as critical tools for decolonizing





knowledge production, preserving cultural heritage, and empowering communities in the diaspora. For her work in decolonial activism, climate justice, and African language advocacy, Njeri was recognized as Historian of the Year 2023. Currently, Njeri works as a consultant for the University of Cologne (UoC), where she develops and advocates for antiracist policies and strategies. This is the first position of its kind in the history of German universities. Her work focuses on creating sustainable structures to ensure the University of Cologne becomes more inclusive for all, while also providing counsel to employees experiencing racial discrimination and supporting the development and implementation of anti-racist strategies across the institution.




Dr. Luanga Nchari

Godian Ejiogu (MA) has worked for more than 25 years as a spiritual caregiver, specializing in culturally sensitive care for African roots in The Netherlands. He knows where he comes from. His community upbringing in his family of birth did not leave him after migrating to the Netherlands. While writing his master's thesis in 1996, he researched the *Spirituality of African people* (very relevant in understanding Africans). In another thesis for his master's diploma in 2007, he researched *Racism against Africans in the multicultural church communities*. It was relevant to understand why migrant or international churches exist. It also exposed the depth of racism in education and its effect on social interaction. Both research and other life work helped him maintain his African identity and professional skills in cultural diversity. He did parish pastoral work in different Roman Catholic dioceses in The Netherlands. Later, he worked as a city pastor in Amsterdam and Rotterdam. Lecturing at different theological universities is his way of maintaining his passion for education. A decade ago, he established the God Peace Ministry. A non-denominational congregation for the spiritual education and cultivation of a community culture of health and living peace. He has established tens of communities, both in Africa, and in Europe. Ejiogu is a community person imbued with the spirituality of union and peace. His writings, both books and articles, are based on promoting and preserving human dignity. Some of his books aim to break taboos by telling untold stories of harm. Encouraging people to tell their personal stories and break their fears and taboos is part of his method of spiritual care, which encourages self-liberation, healing, strengthening of spirit of resilience, and provide peace of mind. Guiding people to find answers to their life questions and peaceful living peace is his primary goal. Living with Dutch origins for almost three decades as an African, both in private and public life, expands his knowledge





culture. As the father of three children born into mixed African and Dutch heritage, he understands the challenge this poses in intercultural upbringing. The question of identity for children and their place of belonging can be traumatizing. Ejiogu is the General Overseer of the Good Peace Ministry. He is the chair and CEO of the Foundation Collectively Strongly Rooted. He is also the director of the Migrant Mother and Child Foundation and owner of Peace Servant (https://peaceservant.nl), including the publishing press.


Stella Simiyu (MA)




Dr. Elizabeth (Eliza) Ngutuku


Dr. Mary Mangai
